Needlestick Injuries – Still a Big Risk



Potential source of danger: Replacing the safety shield on a used needle

Injuries due to contaminated puncture devices are still the most frequent cause of accidents in hospitals. This is a significant source of danger for many employees in the healthcare industry.

Make a decision for the good of everyone

In May 2010 a Directive was introduced to EU member states with the goal to prevent injuries and bloodborne infections from sharps such as needles to hospitals and HCW.

Member states have until May 2013 to implement the provisions of the Directive into their respective national legislations. The aim of the Directive is to, amongst others, prevent healthcare worker injuries caused by all sharps; to protect workers at risk; to set up policies in risk assessment, training, prevention, information and monitoring; to achieve safe working environment and to establish response and follow up procedures.

- ⦿ The safety mechanism must be an integral part of the system, and compatible with other accessories
- ⦿ One-handed activation of the safety mechanism must be possible

- ⦿ The safety mechanism must prevent re-use
- ⦿ It should not be necessary to change application technique
- ⦿ A clear signal, either acoustic or tangible, must indicate to the user correct activation of the safety mechanism

Once activated it is not possible to unthread the used needle, thereby additionally preventing injuries on the backend of the needle sleeve.

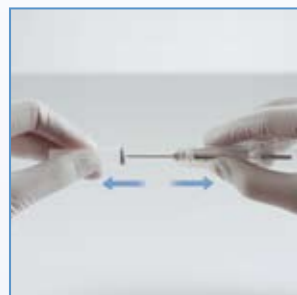

The new product is absolute simplicity, as there is no need for the blood collection staff to manually activate the safety mechanism. The safety engineered design represents automatic safety. The visual indicator on the safety shield provides the user additional assistance in identifying the depth of the needle in the vein.

Activation - TUBE TOUCH:

When the user pushes in the tube, the pressure of the tube onto the back end of the needle releases the safety shield, automatically covering the needle which moves forward lightly resting against patients skin.

The safety shield can then move freely, enclosing the needle via the spring mechanism as it is withdrawn from the vein. Features of the system are extreme comfort and maximum safety, with the additional advantage that the user can collect blood samples as usual and has no additional handling steps. The Product will be available in spring 2011.

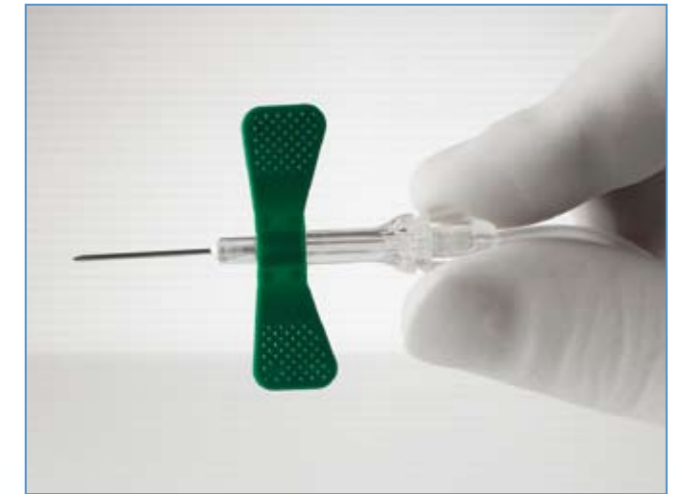

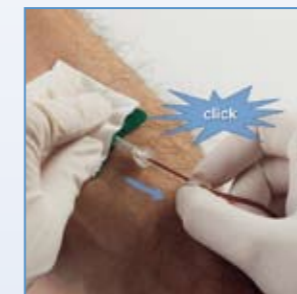
